- 2. The abatement shall not be applicable on the credit Sub-Head/Item for dismantling/demolition.
- 3. You are requested to submit the performance guarantee @ 5% of tender value of work i.e. **Rs.1,86,53,490/-** (Rupees One Crore Eighty Six Lakhs Fifty Three Thousand Four Hundred Ninety only) within **7th days** of issue of this letter. The Performance Guarantee shall be in any of the prescribed form as provided in Clause -1 of the General Condition of Contracts for CPWD Works and shall be valid upto **330 Days.**
- 4. On receipt of prescribed performance guarantee, necessary letter to commence the work shall be issued, and site of work handed over to you thereafter.

- 5. Please note that the time allowed for carrying out the work is **270 Days which shall be reckoned** from the **10**th **day** after the date of issue of this letter of acceptance of tender.
- In case you fail to deposit Performance Guarantee as mentioned above, within the prescribed period, your earnest money shall be forfeited without any further notice.
- 7. The contractor shall obtain necessary licence as required under section 12 of the Contract (Labour regulation and abolition Act 1970) before commencement of the work.
- 8. No running Account Bill shall be paid for the work till the applicable labour licences registration with EPFO, ESIC whatever applicable are submitted by the contractor to the Engineer-in-Charge. The ESI and EPF contribution on the part of employer in respect of this contract shall be paid by the contractor. These contributions on the part of the employer paid by the contractor shall be reimbursed by the Engineer-in-Charge to the contractor on actual basis. The applicable and eligible amount of ESI and EPF shall be reimbursed preferably within 7 days but not later than 30 days of submission of documentary proof of payment provided same are in order.
